The committee-of-the-whole meeting of the Board of Supervisors of Perry Township was called to order by Chairman Lance N. Public Comments:

Nancy James- On Zoom- Liked the new picture of the monument with the flower bed on Facebook. Discussed placement of Recreation Park signs. Chairman Adam said we have enough signs to place one at each intersection that connects to the recreation park along 662. The township will need to make different brackets for those poles.

- 5. **Review Unofficial Minutes** of the Committee Meeting of May 3, 2022, and the Supervisor's Meeting of May 10, 2022. No comments.
- 6. **CELG Municipal Sponsorship-** this will be tabled for another time.
- 7. **Hollenbaugh's Trash Fuel Surcharge-** Hollenbaugh sent out a memo. Due to the rise in cost, they will be charging a \$5.00 monthly fuel surcharge starting in June. A price comparison was done with other local sanitation services. Even with the surcharge, Hollenbaugh is still the best price.
- 8. **File Cabinet Purchase-** The township office is in need of more file cabinet storage. Price quotes were collected from Office Supply, Sams Club, and Staples for FireKing Patriot file cabinets. The best price is from Office Supply at \$1,812.95 each with shipping. Chairman Adam made a motion to purchase 2 FireKing Patriot file cabinets from Office Supply at the price of \$1,812.95 each. Supervisor Dalton seconded the motion. Motion carried with all Supervisors present voting yes.
- 9. **Recreation Board Letter of Interest-** A letter of interest was received from Robert Schaner Jr to fill the vacant seat on the Recreation Board. The Recreation Board accepted Robert's letter at their May 31st meeting. Chairman Adam made a motion to appoint Robert Schaner Jr to the Perry Recreation Board. Supervisor Dalton seconded the motion. Motion carried with all Supervisors present voting yes.
- 10. **Bell Field Dugouts-** Mike Dreibelbis addressed the Board of Supervisors. The Perry Baseball Association would like to construct dugouts at the Bell Field, identical to the dugouts at

the Dietrich Field. The current sponsors are very appreciative of all the work being done at the baseball fields. Chairman Adam made a motion to allow Perry Baseball Association to construct the same dugouts at the Bell Field as the Dietrich Field. Supervisor Dalton seconded the motion. Motion carried with all Supervisors present voting yes.

11. **Eagle Scout Project- Ryan Daly-** Ryan Daly presented his Eagle Scout Project to the Board of Supervisors. His project is to update the existing, deteriorated walkway from the parking lot to the concession stand/ baseball field at the Perry Recreation Park. The proposed pathway will be a 5-foot-wide concrete walkway. Chairman Adam confirmed because the township is the beneficiary, the township is able to supply the 2B stone for the project. Chairman Adam made a motion to allow Ryan Daly to move forward with his proposed Eagle Scout project at the Perry Recreation Park. Supervisor Dalton seconded the motion. Motion carried with all Supervisors present voting yes.

Nancy James- Nancy asked if the township was 2nd or 3rd class? Chairman Adam responded Perry Township is a 2nd class township. Nancy also felt the sound quality on Zoom was better with the new tablet.
