- 4. **Review List of Invoices-** The Hollenbaugh Trash includes disposal of a mattress and box spring, as well as starting the recreation park dumpster for summer. Supervisor Daly questioned if the DES invoice included the contract discount. The answer is yes, we save almost \$2,000.00 with the contract.
- 5. **Review Unofficial Minutes** of the Committee Meeting of February 1, 2022, and the Supervisor's Meeting of February 8, 2022. No comments were made.
- 6. **Weed-eater purchase-** The roadcrew daily-use weed eater is due for an upgrade. Looking at a weed eater with multiple attachments, such as a power broom, trimmer head and bristle brush. Waiting on a final price from Kuzans. Chairman Adam made a motion to purchase a new weed-eater with all the attachments from Kuzans, not exceeding \$1,600.00. Supervisor Daly seconded the motion. Motion carried with all Supervisors voting yes.
- 7. Main Street landscape repair- In order to complete a drainage project, 2 areas on Main Street, behind Schaeffer's RV, are in need of landscape repair. Hilltop gave a quote of \$2,600.00 to remove debris, rake, hydroseed, and add screened topsoil. Chairman Adam made a motion to accept Hilltop's proposal to finish the project on Main Street for \$2,600.00. Supervisor Dalton seconded the motion. Motion carried with all Supervisor's voting yes.
- 8. **PML-L3P Membership Renewal-** Annual Pennsylvania Municipal League L3P Membership renewal is due. Cost is \$65.00. Supervisor Daly elaborated this is a beneficial lobbying firm for municipal governments. Supervisor Daly made a motion to renew our PML L3P membership for the amount of \$65.00. Chairman Adam seconded the motion. Motion carried with all Supervisors voting yes.
- 9. Advertise Part-time Laborer- Going into busy season, the township would like to hire part-time help. Cost-free resources such as the website, Facebook page, and possibly Indeed will be used to advertise.
- 10. **Recreation Park Bathroom Renovation Quote-** The Recreation Board approved a quote from RD Contracting to renovate the recreation park bathroom. The quote includes installation of

FRP panel on ceilings, addition of hot water heater with pex piping, and installation of ventilation in all 3 bathrooms for \$2,600.00. The quote does not include painting of the walls, poxy coating the floors, or stall dividers. Depending on the outcome of stall dividers, the men's bathroom may become a single-use bathroom. The Lion's Club donated \$1,000.00 towards the upgrades. The remaining balance will come from the Recreation Fund. Supervisor Daly made a motion to follow the recommendation of the Recreation Board, hiring RD Contracting to upgrade the bathrooms for \$2,600.00. Chairman Adam seconded the motion. Motion carried with all Supervisors voting yes.
