**In-field Mix-** The baseball fields at the recreation park need one load of in-field mix. Price rate from Martin Stone Quarries is \$32.00 per ton. Supervisor Daly made a motion to approve the purchase of one load of in-field mix from Martin Stone Quarries to not exceed the amount of \$1,000.00. Supervisor Dalton seconded the motion. Motion carried with all Supervisors voting yes.

**Yield Options with Tompkins-** This is an FYI. Administrator Dreibelbis has a meeting with Tompkins bank to discuss different investment yield options. The Supervisors are in favor of this meeting.

Bay 5 Lighting & Bays3/4 Receptacles- Billman Electric provided a quote for 6 LED lights with motion censors in Bay 5. The quote also included ceiling receptacles in Bays 3 and 4. The quote is in the amount of \$3,200.00. Supervisor Daly made a motion to approve the quote from Billman Electric in the amount of \$3,200.00. Chairman Adam seconded the motion. Motion carried with all Supervisors voting yes.

**RISK Training-** RISK stands for Railroad Incident Safety Course. This is being held at the Shoey Fire Company on March 28 from 6-10pm. This is a federal class with a test and earned certificate.
