Mike Dreibelbis made a motion to appoint Robert Schaner Jr as Vice- Chairman of the Recreation Board for 2024. Seconded by Rochelle Dreibelbis. Motion carried. 4. **Meeting Minutes from Recreation Board October 31, 2023-** Mike Dreibelbis made a motion to approve the minutes from October 31, 2023. Robert Schaner Jr. seconded the motion. Motion carried.

5. **Treasurer's Report:** As of December 31, 2023 the balance in the Recreation Fund was \$19,925.23. In January, \$595.00 was deposited from the cell tower lease, \$821.80 deducted for the "Christmas in the Park" donation and scoreboard supplies. Current balance is \$19,698.43. Mike Dreibelbis made a motion to approve the Treasure's Report. Seconded by Robert Schaner Jr. Motion carried.

6. **All Green Weed Spraying-** 2024 contract for weed spraying at the recreation park received from All Green. Same price as previous years. Pre-payment amount is \$950.00. Mike Dreibelbis made a motion to approve the 2024 weed spraying contract with All Green in the amount of \$950.00. Seconded by Robert Schaner Jr. Motion carried.

7. **Lower Parking Lot-** Discussed expanding the lower parking lot. Mike would do the excavation. The parking lot could then be lined with parking spaces for extra parking.

New business:

- There has been more interest in renting the basketball court for league practices.
- The scoreboards are ready to be installed. Waiting on electrical requirements.
- Waiting to hear back from grant application for new concession stand/ pavilion.
- Discussed installing a single, bathroom partition in the men's room. Quotes will be collected for next meeting.
- Discussed concrete at Dietrich Field- backstop, bleacher pads, handicap walk-way.
