The Recreation Board Meeting of Perry Township was called to order by Chairman, David Lindenmuth, at 6:00 p.m. on August 29, 2023 at the Perry Township Recreation Park, 730 Onyx Cave Road, Hamburg, PA.

- A letter of resignation was received from Eliza Hunsicker. Resignation will go to the Supervisor Board on September 5, 2023 for approval. This will leave an open seat on the Recreation Board.

3. **Meeting Minutes from Recreation Board July 25, 2023-** David Lindenmuth questioned when the tree's will be removed between Dietrich and Bell field? In late fall/ early winter. Dave questioned where the UV light system stands. Supervisor Dalton would like to meet with RM Schaeffer to discuss other system options. Mike Dreibelbis made a motion to approve the minutes from July 25, 2023. Robert Schaner Jr seconded the motion. Motion carried.

4. **Treasurer's Report:** As of July 31, 2023, the balance in the Recreation Fund was \$17,744.42. In August, \$595.00 was deposited from the cell tower lease. \$508.00 was deducted for the new basketball backboards. Current balance is \$17,831.42. Mike Dreibelbis made a motion to approve the Treasure's Report. Seconded by Robert Schaner Jr. Motion carried.

5. **Fall Fest-** A group of residents came together to make the "Perry Park Events" group. The goal of the group is to put together township sponsored family events at the park. The first planned event is a "Fall Fest" or "Perry Picnic" on October 14 (October 15-rain day). Discussed different events for that day including kickball, concession stand, smores bags, yard games, live music, pumpkin painting, and a possible hay ride. The group came up with a budget of \$1,074.00 for the event, presented as a request for donation. All proceeds from the event would be submitted to the township to sponsor the next event. Volunteers would help set up and run the event. David Lindenmuth made a motion to approve the donation towards the budget for the "Perry Picnic" event in an amount to not exceed \$1,500.00. Mike Dreibelbis seconded the motion. Motion carried. Discussed future events for the park such as family movie nights and Christmas tree lighting.
