To accept and approve the extension letter from Glen Gery Brick – a motion was made to amend the agenda for the extension letter from Glen Gery Brick, seconded by Jerry Clay and carried.

2 separate submissions:

- 2- Pool parcel (Shoey pool) belonging to Shoemakersville land is all in Perry Township

These applications were transmitted to the borough. Reference of these parcels to be in the plan, to be annexed into Perry Commercial Center.

2 separate submissions:

- 1- Pool plan a motion was made by Gene Buck to review the pool plan, seconded by Dean Adam and carried.
- 2- Supermarket plan a motion was made by Gene Buck to review the supermarket plan, seconded by Dean Adam and carried.

They form the base plan for the Perry Commercial Center – they are asking for conditional approval. The review letter from Ryan Rhode dated 12/28/2022 discussed.
