The committee-of-the-whole meeting of the Board of Supervisors of Perry Township was called to order by Chairman Lance N. 4. **Review List of Invoices-** Supervisor Daly questioned if the radio upgrade with Triangle Communications was complete? The quoted project is complete; however, reception is still not where it should be. Triangle has been working with Chairman Adam on a quote to add 20-30ft onto our antenna for better reception. Administrator Dreibelbis confirmed the Perry Athletic Association did pay half of the infield mix. The salt shipment is complete at just over 600 tons. Supervisor Daly asked if the municipal audit was already advertised? The answer is yes, we are in our 30-day waiting period.

5. **Review Unofficial Minutes** of the Committee Meeting of March 1, 2022, and the Supervisor's Meeting of March 8, 2022. No comments were made.

6. **Annual Municipal Audit Advertisement-** Under Allen Shollenberger's guidance, the Township Supervisor's agreed to advertise for the appointment of a CPA firm to perform the Annual DCED Municipal Audit.

7. **Tablet Purchase-** Four price quotes were collected for the purchase of a township tablet. After research, the Samsung Galaxy Tab A8 seems to be the best option. Supervisor Daly made a motion to purchase a Samsung Galaxy Tab A8 for a price not exceeding \$300.00. Supervisor Dalton seconded the motion. Motion carried with all Supervisors voting yes.

8. **Approval of New Hire-** After website advertisement, the Township received an application from Tyler Heffner, Onyx Cave Road. Tyler is 26 years old and finished his active duty with the United States Air Force. Chairman Adam made a motion to hire Tyler Heffner for part-time road crew. Supervisor Dalton seconded the motion. Motion carried with all Supervisors voting yes.

9. **Hamburg Public Library Donation-** A donation request was submitted by Debbie Wahl on behalf of the Hamburg Public Library. Supervisor Daly reviewed the library's past year statistics. The Township donated \$2,500.00 to the library last year. Supervisor Daly made a motion for the Township to continue with their annual donation to the Hamburg Public Library in the amount of \$2,500.00. Chairman Adam seconded the motion. Motion carried with all Supervisors voting yes.
