The committee-of-the-whole meeting of the Board of Supervisors of Perry Township was called to order by Chairman Lance N. **Public Comments:**

**Nancy James-** On Zoom- Asked for rock salt at the recreation park.

**Review List of Invoices-** No comments.

**Review Unofficial Minutes** of the Committee Meeting of July 5, 2022, and the Supervisor's Meeting of July 12, 2022. No comments

**Recreation Parking Lot-** The parking lot at the recreation park needs to be paved before it is lost. Working with Ryan Rhode from Kraft and Folk Paving, Folk provided a rough estimate for the job of \$46,000.00. This topic was tabled for next meeting.

**Township Credit Card-** The current township credit card is through Sam's Club. Due to repetitive issues with their billing department, the township would like to look into a different credit card. A comparison of different business credit cards was put together, one being through Tompkins Bank. This topic was tabled for next meeting.

**External Radio Speaker Quote-** Due to where the radios are mounted in the equipment, they are very hard to hear. For safety purposes, the roadcrew would like external speakers mounted for each radio. A quote was obtained from Triangle for 10 external radio speakers in the amount of \$540.00. Supervisor Dalton questioned if ear pieces would be another option? Deane Hamm feels with ear pieces, you cannot hear the equipment properly. Chairman Adam made a motion to purchase 10 external radio speakers from Triangle Communications in the amount of \$540.00. Supervisor Daly seconded the motion. Motion carried with all Supervisors voting yes.

**Larger Chainsaw for Roadcrew-** The roadcrew feels it would be beneficial to have a larger chainsaw. Chairman Adam collected quotes from Reading Kabota and Kuzans for a chainsaw with a 36-inch bar. The best price was from Kuzans in the amount of \$1,099.00. Supervisor Daly made a motion to purchase a 36-inch bar chainsaw from Kuzans in the amount of \$1,099.00. Chairman Adam seconded the motion. Motion carried with all Supervisors voting yes.

**Guiderrails-** 3 companies were contacted for quotes on replacing/repairing 5 guiderrails throughout the township. Collinson Inc was the only company to respond with an itemized quote.

5 different areas were quoted (Dreibelbis Mill Rd, Five Locks Rd, Zions Church Rd, Laurel Rd, and Skyline Drive) for a total amount of \$20,200.00. Supervisor Daly questioned, financially, what would happen if the guiderail was damaged after replacement? If a police report is filed, a property damage invoice can be sent to the guilty party's insurance. More quotes will be obtained before a decision can be made. Kathy DeCarlo (on Zoom) was glad the price is being questioned.

**\*Chairman Adam made a motion to amend the agenda for the addition of sending tree removals out for bid. Supervisor Daly seconded the motion. Motion carried with all Supervisors voting yes.**

10. **Tree Removal Bid-** There are 9 trees throughout the township to be removed. Chairman Adam made a motion to send the tree removal list out for bid. Supervisor Dalton seconded the motion. Motion carried with all Supervisors voting yes.
