Review Unofficial Minutes of the Committee Meeting of October 4, 2022, and the Supervisor's Meeting of October 11, 2022. No comments

Perry Athletic Association- Perry Athletic Association submitted a formal request for a donation from the ARPA funds. The request is in the amount of \$5,350.00. The purpose is for fencing and concrete around the backstop of Bell Field at the Perry Recreation Park to increase accessibility and safety for players and spectators. Supervisor Daly made a motion to grant the request from Perry Athletic Association in the amount of \$5,350.00. Chairman Adam seconded the motion. Motion carried with all Supervisors voting yes.

DCNR Grant Resolution- The township applied for another walking path grant through DCNR. A resolution agreeing to the terms and conditions of DCNR's grant process needs to be passed for completion of the application. Chairman Adam made a motion to adopt the DCNR Resolution using WebID # 2005909. Supervisor Daly seconded the motion. Motion carried with all Supervisors voting yes.

Christmas in the Park Donation- The Perry Township Recreation Board voted to donate \$1,000.00 from the Recreation Fund, towards "Christmas in the Park". Chairman Adam made a motion to approve the \$1,000.00 donation from the Recreation Fund towards "Christmas in the Park". Supervisor Dalton seconded the motion. Motion carried with all Supervisors voting yes.

*Supervisor Dalton made a motion to amend the agenda to add purchase of salt additive system. Chairman Adam seconded the motion. Motion carried with all Supervisors voting yes.

Salt Additive System- The township is looking to convert to a salt system similar to Tilden Township. The system mixes an additive with the road salt. The system is approximately between \$11,000- \$12,000 up-front. Pros to the system are: more ecofriendly, not as corrosive on equipment, and activates at a lower temperature. Supervisor Dalton made a motion to purchase the equipment needed for the salt additive system in an amount to not exceed \$13,000.00. Supervisor Daly seconded the motion. Motion carried with all Supervisors voting yes.
