3. **Re-organization:** Robert Schaner Jr made a motion to nominate Mike Dreibelbis as Chairman of the Recreation Board for 2026. Seconded by Dave Lindenmuth. Motion carried. Mike Dreibelbis abstained. Mike Dreibelbis made a motion to nominate Robert Schaner Jr as Vice-Chairman of the Recreation Board for 2026. Seconded by Dave Lindenmuth. Motion carried. Robert Schaner Jr. abstained. Mike Dreibelbis made a motion to nominate Rochelle Dreibelbis as Secretary of the Recreation Board for 2026. Seconded by Robert Schaner Jr. Motion carried. Rochelle Dreibelbis abstained. Re-organization is as follows:

4. **Meeting Minutes from Recreation Board August 26, 2025-** Since last meeting, the parking lot has been sealed. The walkway to the bathroom will be sealed in spring, as well as, parking space line painting. Chairman Dreibelbis made a motion to approve the minutes from August 26, 2025. Bob Schaner seconded the motion. Motion carried.

5. **Treasurer's Report:** As of January 31, 2026, the balance in the Recreation Fund was \$18,937.73. In February, \$684.40 was deposited from the cell tower lease, and \$60.00 deposited for a rental. Current balance is \$19,682.13. Chairman Dreibelbis made a motion to approve the Treasurer's Report. Seconded by Bob Schaner. Motion carried.

6. **Dutchman Payment Application #3:** This is the final payment application. There is a one-year warranty on the building. The final payment application is in the amount of \$10,054.45, and is 100% grant funded. Chairman Dreibelbis made a motion to approve the final payment application to Dutchman Contracting in the amount of \$10,054.45. Bob Schaner seconded the motion. Motion carried.

7. **New Pavilion Rental Contract:** Reviewed a draft rental contract for the new pavilion. Discussed pavilion only vs pavilion and concession stand rentals. Compared pricing to Shoey Boro and Tilden Township. Discussed the conditions that would be set for renting the concession area (ie. Not using baseball cooking appliances, locking the baseball fridge and freezer, credit card on file required, adding clean-up clause or deposit forfeited)

**New Business:**

- Collecting picnic table quotes for the new pavilion.
- Looking at cameras for the new pavilion.
- As a one-year trial, a travel softball team will be using the lower field as a practice field. If the organization wishes to continue using the field, they are willing to help fund field up-grades.
- Meeting with Russ on Thursday to discuss electric.
- Playground will be mulched
