The Recreation Board Meeting of Perry Township was called to order by Chairman David Lindenmuth, at 7:00 p.m. on January 25, 2022 in the Township Municipal Building, 680 Moselem Springs Road, Shoemakersville, PA.

3. **Re-organization of Recreation Board-** A motion was made by Mike Dreibelbis, seconded by Rochelle Dreibelbis to reappoint David Lindenmuth as Chairman. Motion carried; David abstained. A motion was made by David Lindenmuth, seconded by Rochelle Dreibelbis to reappoint Mike Dreibelbis as Vice-Chairman. Motion carried; Mike abstained. Motion was made by David Lindenmuth to reappoint Rochelle Dreibelbis as Secretary, seconded by Mike Dreibelbis. Motion carried.
4. **Meeting Minutes from Recreation Board November 30, 2021-** David Lindenmuth made a motion to approve the minutes from November 30, 2021. Mike Dreibelbis seconded the motion. Motion carried. The December 2021 meeting was canceled.
5. **Baseball Field Fencing-** Received a quote from Forte Contracting LLC for closing in the 2 baseball fields with 4ft high chain-link fence. The amount is \$13,659.54. Two more quotes are going to be requested.
6. **Baseball Upgrade Donations-** A donation request was submitted to Sheetz but was denied. Jessie Adam is donating his time and equipment to remove the old batting cage. Dustin Folk agreed to pave the 15x70ft area for \$1,500.00. Mike Dreibelbis is waiting on contact with Troy Adams from NFI regarding a donation towards the batting cage. Other warehouses will be approached for donations towards electronic score board.
7. **Backpack Blower-** Dave is going to request a quote for a backpack leaf blower and mixed gas can at Reading Tractor and Equipment through the township account. The Perry Baseball Association will provide a check for half of the amount.
8. **Bathroom Renovation-** The Wagner brothers are providing a quote for bathroom renovation. A quote is also going to be requested from Steve Bashore and another company. The portable toilet is going to be requested for mid-March for baseball field clean-up and practices.

New Business: Martin Stone Quarry will be contacted for Infield Mix quote- one truck load. A list of new playground equipment is going to be compiled. Lance Adam completely agreed with updating the equipment. Grant funding is looking to be obtained for the recreation park. The old equipment could possibly be sold on Municibid.
