4. **Meeting Minutes from Recreation Board October 29, 2024-** Chairman Dreibelbis made a motion to approve the minutes from October 29, 2024. Robert Schaner Jr seconded the motion. Motion carried.

5. **Treasurer's Report:** As of December 31, 2024, the balance in the Recreation Fund was \$15,964.65. In January, \$1,368.80 was deposited from the November and December cell tower lease. Current balance is \$17,333.45. Chairman Dreibelbis made a motion to approve the Treasure's Report. Seconded by Robert Schaner Jr. Motion carried.

6. **Concession/Pavilion Project-** Bid advertisement ran on 1/17/25 and 1/27/25. Walk through at the project site will be 2/13/25 at 10:00 AM. Bids due at the township office by 2/28/25 at 11:00 AM. Once the building is underway, Rochelle will shop for tables and appliances with the remainder of the grant allotment.

- Working on collecting a 3rd quote for a gator with a dump body.
- Need a cost estimate for the new electrical supply to the pavilion, baseball/township shed, and lighting. Electrical is not included in the bid.
