The Recreation Board Meeting of Perry Township was called to order by Chairman, David Lindenmuth, at 7:00 p.m. on July 25, 2023 at the Perry Township Recreation Park, 730 Onyx Cave Road, Hamburg, PA.

3. **Meeting Minutes from Recreation Board June 27, 2023-** Mike Dreibelbis made a motion to approve the minutes from June 27, 2023. Robert Schaner Jr seconded the motion. Motion carried.

4. **Treasurer's Report:** As of June 30, 2023, the balance in the Recreation Fund was \$16,650.25. In July, \$1,050.00 was deposited: \$595.00 from the cell tower lease, \$195.00 in donation from Perry Elementary, and \$260.00 in park rentals. The current balance is \$17,700.25. The basketball backboard purchase will be reflected on the next credit card statement, which will be deducted from the recreation fund. Mike Dreibelbis made a motion to approve the Treasure's Report. Seconded by Robert Schaner Jr. Motion carried.

5. **Tree Removal-** Discussed the removal of the 3 trees between Dietrich and Bell Field. Township will cut down and stumps ground. Mike Dreibelbis made a motion to approve the removal of the 3 trees. Seconded by Robert Schaner Jr. Motion carried.

6. **UV Light System-** A quote was obtained from R.M. Schaeffer for the installation of a UV sterilizer at the main water source for the recreation park. This would eliminate the constant bacterial contamination issue for the bathrooms and concession stand. The quote is in the amount of \$1,969.00, which does not include digging/trenching. Mike Dreibelbis made a motion to move forward with the UV light sterilizer at a cost to not exceed \$2,500.00. Rob Schaner Jr seconded the motion. Motion carried.

Other Business:

- Discussed the scheduled "Fall Fest". A group, "Perry Park Events", is coordinating. Discussed issues with having an open fire pit for smores. Discussed funding options. Members of the group will be encouraged to attend the next Recreation Board meeting to discuss further.
- The parking lot still needs to be sealed.
- No correspondence with soccer regarding practice fields at the park.
- Reaching out to the boy scouts for building trash enclosers. Rec Board would cover material costs.
