The Recreation Board Meeting of Perry Township was called to order by Vice-Chairman Mike Dreibelbis, at 7:00 p.m. on September 27, 2022 at the Township Municipal Building, 680 Moselem Springs Road, Shoemakersville, PA.

3. **Meeting Minutes from Recreation Board August 30, 2022-** Mike Dreibelbis made a motion to approve the minutes from August 30, 2022. Robert Schaner Jr seconded the motion. Motion carried.

4. **Treasurer's Report:** As of August 31, 2022, the balance in the Recreation Fund was \$15,562.22. \$595.00 was deposited from the cell tower lease. The current balance is \$16,157.22.

5. **Painting Quotes-** A quote was received from D.Z. Miller to paint the exterior of the bathroom, the block on the new dugouts, and the wood on the old dugouts. Total cost is \$2,246.40, including labor and materials. Mike Dreibelbis made a motion to approve the painting quote from D.Z. Miller. Robert Schaner Jr seconded the motion. Motion carried. Mike would also like a quote for painting the fencing at the bathrooms.

6. **Playground Update-** Excavation of the area will be October 8, including removal of the slide. D. Z. Miller will also be contacted for installation of the playground equipment, with the help of some volunteers. A skid loader with auger will be rented from Kuzans. Other needed material is quick-crete, which can be purchased at Kuzans. Hoping to install the equipment the weekend of October 15, depending on D.Z. Miller's availability. \$30,000.00 was allotted from ARPA funds for this project, which will cover materials and labor.

**New Business:**

- Repainting of the dome
- **Nancy James-** In discussion of park improvements/beautification, Nancy suggested/would like to add 2 park benches at the park. One of the benches, Nancy would like to donate in honor of her late husband Kenny. One bench would be placed where the large bushes were removed, the other next to the handicap ramp at the bathroom. The recreation board feels both would be a great addition to the park. Nancy selected 2 benches, and is also working with Kuzan's on what they may have available. How to anchor the benches was discussed.
- Suggestion of adding a sign to the sand toy box to please clean up toys before leaving.
