Perry Township Recreation Area Park Rules

1. Anyone found destroying/damaging park property will be fully responsible for all repairs.
2. No dogs/domestic animals allowed on the property
3. Perry Township and the Perry Township Recreation Board are not responsible for personal injury or liability in connection with use of the facilities.
4. No alcoholic beverages, lethal weapon, or illegal drugs, or drug paraphernalia are permitted on Park property.
5. No littering. Trash cans are to be used.
6. No open fires are permitted.
7. The park must be left in the condition that is found.
8. No bicycles are permitted on Park grounds.
9. No glass containers except under the Pavilion.
10. Each organization shall be responsible for the conduct of all persons present for the organizations activities and in the event of damage to the buildings or equipment owned by the Township, the organization shall be responsible for the correction of the damage.
11. Park Hours of Daily Operation are Sunrise to Sunset.
